

Website Terms of Use

1. General

- (a) www.thetodaybusiness.com.au is a site operated by The Today Business Pty Ltd ACN 627 299 889 (**we, us or our**).
- (b) These terms of use (**Terms**) (together with documents referred to in it) governs the terms of use under which you may make use of our products, services and website www.thetodaybusiness.com.au (collectively referred to as the **Site**). The term **you** refers to the person or organisation accessing, using or relying upon the Site.
- (c) Please read these Terms carefully before you start to use the Site. By using, browsing or accessing the Site, you indicate that you have read, understood and accept these terms and conditions of use, together with our Privacy Policy, and that you agree to abide by them.
- (d) We encourage you to read these Terms and to contact us by email at info@thetodaybusiness.com.au if you have any particular questions in relation to the use of the Site. If you do not agree to these Terms, you may not access or otherwise use the Site and the Services offered on the Site.

2. Accessing the Site

- (a) We will not be liable if for any reason the Site is unavailable (wholly or partly) at any time or for any period.
- (b) From time to time, we may restrict access to some parts of the Site (wholly or partly).
- (c) You are responsible for making all arrangements necessary for you to have access to the Site. You are also responsible for ensuring that all persons who access the Site through your internet connection or mobile telephone are aware of these Terms, and that they comply with them.
- (d) When accessing and using the Site, you must:
 - (i) not attempt to undermine the security or integrity of our computing systems or networks or, where the Site is hosted by a third party, that third party's computing systems and networks;
 - (ii) not use, or misuse, the Site in any way which may impair the functionality of the Site, or other systems used in the course of delivering the Site, or impair the ability of any other user to use the Site;

 - (v) not attempt to modify, copy, adapt, reproduce, disassemble, decompile or reverse engineer any computer programs used to deliver the Site.

3. Registration

- (a) You do not need to register or log-in to view the public content and information on the Site. You need an account to access the Today.App through the Site.
- (b) Any personal data or information provided by you is processed by us in accordance with our Privacy Policy. By using the Site and providing any such data or other personal information, you consent to such processing and you warrant that all information provided is true and accurate. You will update this information in order to keep it current, complete and accurate.

4. Site changes

We may, but are under no obligation to, update the Site (wholly or partly) at any time. If the need arises, we may suspend or cease access to the Site. Any of the material provided on, or via the Site, may be out of date at any given time, and we are under no obligation to update it, unless required to do so by law.

5. Policies and guidelines

You shall comply with our policies and guidelines as they apply from time to time.

6. Third party websites

8. Intellectual property

9. Limitation of liability and indemnity

 - (A) personal injury or death to you or any third person;
 - (B) special, direct, indirect or consequential loss or damage; or
 - (C) loss of income or revenue, loss or interruption of business, loss of profits, revenue or contracts, loss of anticipated savings, loss of data, loss of use, loss or privacy, loss of goodwill, wasted management or office time and for any other loss or damage of any kind,
- in any way connected with the Site, the products or services, or in connection with the use, inability to use, or results of the use of the Site,

any social media pages and websites linked to it and any IP Content posted on the Site.

- (c) Without limitation to the foregoing, we acknowledge that the laws in certain jurisdictions including Australia may imply warranties and conditions or impose obligations on the supply of goods and services through or by means of the Site which cannot be excluded, restricted or modified except to a limited extent. If any such laws apply, then to the fullest extent permitted by the law of the relevant jurisdiction, and in the case of Australia to the extent permitted by the Competition and Consumer Act 2010 (Cth), our liability is limited, and if any liability remains it will be limited to any one or more of the following in our sole discretion:
 - (i) in the case of any products, the replacement or repair of the products, or the supply of equivalent products, or the payment of the cost of repairing or replacing the products or supplying equivalent products; and
 - (ii) in the case of any services, the supply of the services again or the payment of the cost of having the services supplied again.
- (d) You have sole responsibility for adequate security protection and backup of data and/or equipment used in connection with your usage of the Site, products and services and will not make a claim against us for lost data, re-run time, inaccurate instruction, work delays or lost profits resulting from the use of the Site, our social media linked pages products or services.
- (e) Without limitation to the foregoing, you agree that in no event shall our maximum aggregate liability exceed one hundred dollars (AUD\$100.00). You agree to indemnify us, our directors, officers, affiliates, employees, partners and representatives from and against all actions, claims, suits, demands, damages, liabilities or costs (including legal costs) arising from, as a result of, or which is directly or indirectly related to:

11. Viruses and hacking

13. No waiver

- (a) If we fail, at any time, to insist upon strict performance of your obligations under these Terms, or if we fail to exercise any of the rights and remedies we are entitled to under these Terms, this will not constitute a waiver of such rights or remedies and it will not relieve you from compliance with your obligations.
 - (b) If we waive a default, this does not constitute a waiver of any subsequent defaults.
 - (c) No waiver is effective unless it is expressly stated by us to be a waiver and is communicated to you in writing.

14. Severability

If any court decides that any of the provisions of these Terms are invalid, unlawful or unenforceable to any extent, that term will, to that extent only, be severed from the remaining terms. The rest of these Terms will continue to be valid.

15. Governing law

These Terms are governed by the laws of the state of Victoria, Australia and each party submits to the jurisdiction of the courts of the state of Victoria, Australia.

16. Variations to these Terms

- (a) We reserve the right, in our sole discretion, to change, modify, add or remove any part of these Terms, in whole or in part, at any time. Notification of the changes to these Terms will be posted on the Site and will be effective immediately, unless expressed otherwise.
 - (b) It is your sole responsibility to periodically check these Terms for any changes. If you do not agree with any of the changes to these Terms, it is your sole responsibility to unsubscribe from the Site. Your continued use of the Site will be deemed as your acceptance thereof.
 - (c) We may assign or sublicense any of our rights or obligations under these Terms at any time without obtaining your consent.
